

Minor Media License 2023

- Provides the right to use music on the internet, in radio and local TV operations as well as download services.*
- Does not cover advertisement or marketing content. In addition to product and service presentations, marketing content is deemed to include, for example, brand and challenge videos created by companies or corporations for social media channels. Using music in advertisement or marketing content is always subject to permission from the music's publisher or, for unpublished music, the author. Please contact our customer service for the contact information of publishers and authors.
- Only suitable for companies or corporations with a maximum annual revenue of EUR 50,000 from the above-mentioned operations and services.
- Covers video and audio content, both free of charge and subject to a charge to consumers, that includes music.
- Does not cover live streams or recordings of gigs and concerts.
- Streaming gigs, concerts and other events, the principal content of which is music, always requires a License for live streaming, if said gigs, concerts or events are subject to a charge to consumers.
- Streaming gigs and concerts that are free of charge to consumers also requires a License for live streaming if they are streamed via a platform other than a platform licensed by Teosto (such as an own website). The platforms licensed by Teosto include YouTube, Facebook and Instagram.
- The basic price of the license includes audio recordings in addition to live streaming. For an additional fee (the so-called Synchronisation surcharge), the license will also cover video recording created from the live streams as well as separately produced video recordings containing music.
- The person acquiring the license does not need to report the information pertaining to the use of music. The remunerations accrued through the license are paid to the music authors on the basis of the music use reports of the radio and concert areas.
- In addition to this license, the use of recorded music requires permission from the producer of the recording, i.e. the record label.

*The Minor Media License is only required for platforms and services, which do not have a separate agreement in place with Teosto (such as own websites, intranet, Zoom, Teams, Vimeo).

Downloads = files that are downloaded from a service to one's own platform (laptop, USB flash drive, etc.)

If the exact same content is being shared as a recording on various platforms, its music minutes are added to the total only once. If a live stream uses a platform licensed by Teosto (YouTube, Facebook, Instagram) and no recording of the live stream is made available afterwards, it does not need to be included in the total music minutes. If the amount of music increases or decreases to such an extent that it is necessary to change the license category either temporarily for a specific period of time or permanently, please contact us at medialicensing@teosto.fi.

Synchronisation surcharge

A synchronisation surcharge must be paid if music is added to a (self-produced) video or a live stream that contains music is video-recorded for later viewing. This applies to both content that is free of charge and subject to a charge to consumers.

Added to the monthly price of a license.

Synchronisation surcharge: 20% For example, for the free-of-charge category M: €108.93/month + 20 % added to the price of the category synchronisation surcharge €21.79/month = €130.72/month.

All prices are subject to VAT of 10%.

Synchronisation = adding and reproducing music in a moving image.

Downloads = files that are downloaded from a service to one's own platform (laptop, USB flash drive, etc.)
